

Quote Specifications for Tablets

Ionia Dial-A-Ride (IDART) is seeking quotes for nine (9) Windows based 10 inch or larger tablets that will be mounted in public transit buses and interface with our current scheduling and dispatching software system. Please note that we are a tax exempt entity. This project is funded 100% with federal/state dollars and any award made is subject to approval by Michigan Department of Transportation (MDOT). This project is **NOT** MiDeal eligible. The lowest quote received from a responsive and qualified party that meets or exceeds the below specifications shall be awarded the purchase. Winning vendor must sign MDOT Appendix B, Certification of Compliance with Federal Contract Clauses (attached) prior to any action occurring on this project.

Tablet Specifications

Windows 10 based operating system

Must be compatible with PC Trans scheduling and dispatching system, which requires only a Windows based tablet to be compatible

IDART must be able to load software onto the tablet

Must be capable of having Verizon Wireless connectivity (area service)

Font, resolution, and brightness of screen needs to be adjustable

In vehicle charger

Minimum 10 (ten) inch screen

Minimum of 16GB of storage space

Must have heavy duty protective case that is adaptable to mount in a vehicle

Additional Specifications

Vehicle mounts included with the tablets

Additional **vehicle** charger with each tablet if not compatible with generic chargers

Charging/docking station included for recharging in office each night

At least a one year warranty – **that covers what you would normally recommend**

Option to purchase additional units at quoted price for up to 6 months

Quote Due Date

Written quote for the nine (9) tablets including mounts, charging station and warranty must be received no later than 09/25/2017 at the Dial-A-Ride office at 251 E Adams Street, Ionia, MI 48846. Quote can be submitted via mail, email, fax, or in person. Quote **must** include company name, contact person, telephone number and/or email address. Deadline for submitting questions regarding this project is 09/18/2017. Tablet Delivery

Vendor must be able to make delivery no later than **11/15/2017**. Please provide an estimated delivery date with the quote. Invoice for the project must be submitted to IDART at the time of delivery.

IDART will make payment to selected vendor, upon satisfactory delivery of **tablets**, within 30 calendar days.
