**The following procedures must be adhered to:**

- Meal receipts are not required. Individual requesting a meal allowance will enter the full applicable meal allowance rate for the specific meal(s) regardless of the cost incurred. RTAP will not pay the actual expense of the meal(s) incurred.
- Individual must have travelled more than 25 miles from both their home and official workstation to qualify for meal allowance.
- To be eligible for a meal expense, the travel must occur as outlined below.  
Breakfast: Travel commences prior to 6:00am and extends beyond 8:30am.  
Lunch: Travel commences prior to 11:30am and extends beyond 2:00pm.  
Dinner: Travel commences prior to 5:00pm and extends beyond 8:00pm.
- Meal allowance amount includes tip.
- Receipts must be provided for all other expenses such as tolls, taxis, air travel, lodging, registration fees.
